One of the strengths of the Niagara Community Foundation is our ability to be both reflective on our successes and challenges while continuing to be forward thinking in bringing new opportunities to Niagara.

The impact of flat returns in 2011 was reflected in a decline in grants in 2012. This was the third downturn in the markets since our launch in 2000. As a result of this trend and the impact on our granting programs, the Board made a decision to connect with each of our fund holders to determine what was a higher priority for the donor: to protect the

capital in their fund or to always make an annual distribution to support the fund beneficiaries. This change has positioned the Foundation to maintain and increase our impact in the community.

Since 2008, the Foundation has invested in the Living in Niagara report, a document which examines the health of Niagara relative to other Canadian communities according to a number of indicators. In recognition of the quality of the data and range of sectors covered, the Board expanded the discretionary grant criteria to give priority to applications which reference data, recommendations or trends in the report.

The bittersweet part of the work of the Foundation is how our growth is affected by the passing of our donors. This report notes that our assets grew by 65 per cent as a result of significant gifts received through bequests. These gifts are supporting organizations and causes important to the donor during their lifetime, and as a result benefit our community in many ways.

The other major change for 2012 stemmed from the Foundation's review of our investment policies. A new investment policy was adopted in partnership with the Toronto Community Foundation. We also made a commitment to a new type of social finance investment, joining other community foundations in investing in the voluntary sector.

Please take some time to check out pages 29-30 of this report where you will see our volunteers and supporters acknowledged. Our success, for which we are extremely grateful, would not be possible without these people and organizations.

PRIORITIES, STRATEGIES, PLANS

HIGHLIGHTS

In 2008, the Niagara Community Foundation adopted a strategic plan based on extensive consultation with the community. At the Foundation's 2011 board retreat, strategic priorities were reviewed and adopted to continue through to 2014. The priorities are reviewed and assessed annually and in 2012 the board confirmed its commitment to these areas, which include:

- Increasing our impact in the community
- Building relationships with key influencers
- Enhancing our role as a community leader
- Building organizational capacity

In accordance with our plan, we achieved the following in 2012:

- Developed and implemented community outreach to key community leaders and potential donors, achieving 110% per cent of contact goal
- Made a commitment to invest \$500,000 in the Community Forward Fund, a social finance investment
- Worked in partnership with the Business Education Council and First Ontario Credit Union to implement a micro-finance initiative
- Convened a group of agency leaders called Change the Game to share resources, professional development opportunities and provide peer support
- Aligned Community, Youth and Mini Grant Program criteria with issues identified in the 2011 Living in Niagara Report
- Worked with fund holders to amend agreements to provide greater flexibility in supporting fund beneficiaries

- Increased transparency in financial reporting in our Annual Report, which garnered a \$5,000 prize from Queen's University Voluntary Sector Reporting Award competition
- Created new Smart & Caring Community Funds supporting: Children and Youth; Health and Well-being; Education and Leadership

We realize that collaborative partnerships with funders and other organizations will go a long way toward ensuring that our grant recipients, their clients and our donors receive quality service and support from the Foundation. Here are some examples of how the Foundation has partnered with others:

NIAGARA NEIGHBOURHOOD GOOD IDEA FUND

The Foundation partnered with the United Way and the Trillium Foundation, pooling their financial resources to develop a small grants program to support innovative projects at the neighbourhood level.

NIAGARA PROSPERITY INITIATIVE

The Niagara Prosperity Initiative (NPI), funded by Niagara Region, is a partnership of public, private and voluntary organizations working to reduce poverty in Niagara. In 2012, we received funding to support the position of Convenor, enabling us to bring organizations together to share resources, implement best practices and collaboratively access funds to support a variety of poverty-reduction initiatives, including community gardens across Niagara. Staff from the Foundation also assisted with the review of the grant applications for \$1.2 million in NPI funding.

MICRO-FINANCE INITIATIVE

In partnership with First Ontario Credit Union and the Business Education Council, the Foundation invested in Niagara's first micro-finance initiative. Modeled after a similar program in Hamilton financed by First Ontario, the Foundation's Niagara Prosperity Convener brought the parties together to replicate this initiative in the region. People applying for the loans are mentored by agencies throughout Niagara that provide pre- and post-loan guidance and support. The program normalizes the banking relationship between individuals and the credit union, providing emerging entrepreneurs the opportunity to move off social assistance.

COMMUNITY FORWARD FUND

At its November meeting, the Board made a commitment to invest \$500,000 in the Community Forward Fund (CFF) in 2013. The decision was reached after 18 months of due diligence and research. This investment is a type of social finance investment where the primary goal is to support organizations serving a social or environmental good above achieving a competitive financial return. Typical investments could include loans for capital projects, providing bridge financing or mortgages. The Foundation is encouraging Niagara-based agencies looking for this type of financing to connect with CFF.

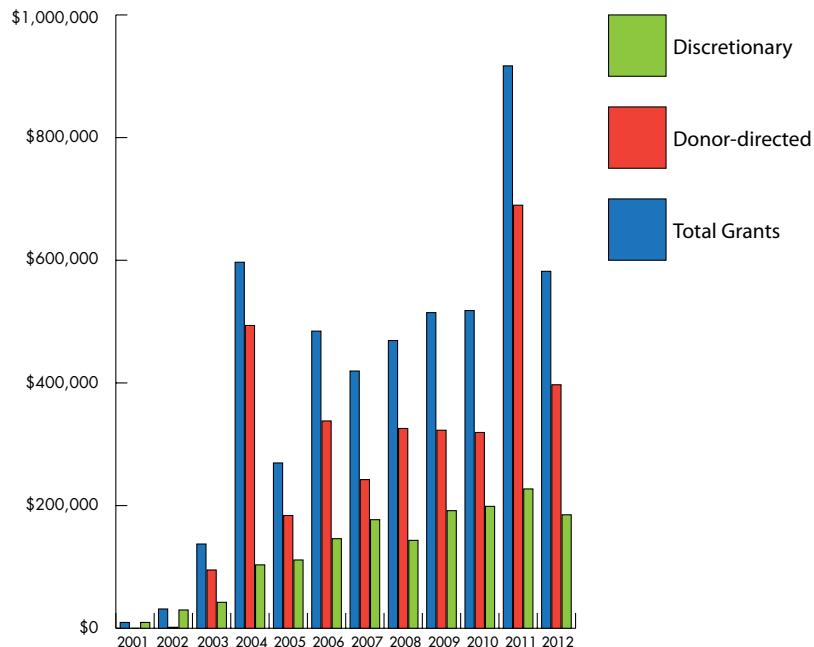

GRANTS ENABLE COMMUNITY DREAMS

PROMOTING GOOD FOOD

The Good Food Box program was created by Gateway Residential and Community Support Services, an agency which enables individuals with serious mental illness to achieve greater independence through innovative consumer-centre housing and support services.

The program is a volunteer-run, produce-buying cooperative to help everyone to include more fresh fruits and vegetables in their meals. This low cost regional program is made possible because of group wholesale buying. Gateway consumers provide the volunteer labour for sorting and packing which also keeps the price down.

Tim Willick, a Gateway consumer, along with the Good Food Box host sites identified that many more people would take advantage of the program if they had methods of remembering ordering dates and were provided with facts about nutrition, recipes and information on food preparation techniques to assist program participants in consuming the fruits and vegetables in the Good Food Box.

The \$500 grant from the Foundation was used to create an 18-month calendar, which was created and coordinated by four Gateway consumers. *

NEW SEED-LENDING PROGRAM

Loan some seeds, watch them grow, harvest some seeds and share the wealth.

That's the vision behind a new program being offered at the Grimsby Public Library. Developed by Adrienne Charette, head of public services, the concept is something in which she had an interest.

After seeing that such programs were becoming popular at libraries in the United States, Charette pitched the idea and successfully applied for a \$200 grant, launching the program in June. The seed library is located in the centre of the library adjacent to gardening books, placed nearby for handy reference.

There is no cost to sign out seeds. The program allows library members to check out seeds, grow vegetables and return harvested seeds at the end of the growing season. This makes the program self-sustaining.

Charette noted that with Niagara's rich agricultural tradition, the program is a great fit for the community. The seed library is open year round and since the launch of the program other libraries in Ontario have expressed interest in starting their own seed-lending program. *

SUPPORTING NIAGARA'S FRANCOPHONE SENIORS

Since 1988, Le Centre polyvalent des aînés francophones de Port Colborne has supported seniors in its community offering programs to alleviate isolation, improve mobility and celebrate francophone culture. Their building is home to recreational, educational and cultural programs.

Its educational programs help with translation and intergenerational programs. The social programs include visits to hospitalized members, friendly check-in phone calls, monthly suppers and dinner dances for special occasions. Exercise programs, arts and crafts classes, billiards, bingo and shuffleboard provide recreational opportunities for their members. Specialized services include income tax clinics, computer courses and a diabetic foot care clinic.

With a \$500 grant from the Foundation, a new library of francophone DVDs was created. The library includes fictional films, exercise videos and documentaries originating from Quebec and having French content. A group of volunteers were recruited to select the DVDs and also to organize a new program called “Les petits mercredis,” a monthly movie/activity day for members.

Initially, the DVD library will be used by their members. However, the ultimate goal is to work with Francophone clubs and organizations across Niagara as well as the French schools in the area. This grant is a great example of the impact a small grant can have in keeping seniors connected to their community. *

ITALIAN COMMUNITY COMING TOGETHER TO BUILD COMMUNITY PLAYGROUND

Club Italia's playground in Niagara Falls has been well used by a generation of children during the past 20 years. However, the equipment was never accessible and, due to its age, was being used less and less.

Members of the club came together to plan and design a new playground, one which could be used by families with young children and that was fully accessible. A core group of volunteers with skills as diverse as engineering, education, health, finance, design and marketing spent many hours on all aspects of this project.

Their goal to raise \$80,000 was helped with a grant of \$5,000 from the Foundation. Alfidone Construction has donated equipment and labour for all the preparation work required for the site along with the installation of the playground equipment and surfacing. As well, 20 club members have agreed to help install the recycled rubber tire surfacing for the playground.

People helping people – that's what community is all about. *

ONE THING LEADS TO ANOTHER...

Sometimes it only takes looking next door to see what works well. Literacy Link Niagara became aware of a program in Hamilton and approached the Foundation for a grant of \$4,480 to replicate it in Niagara.

Typically, clients of the various literacy groups participate in programs at the organizations' offices or in their classrooms. However, there are agencies and individuals in the community who did not know about the programs or literacy assessments.

With its grant, Literacy Link Niagara, a coalition of adult basic education literacy programs, created community hubs, similar to those created in Hamilton. An assessor from the local adult literacy network works throughout Niagara in community spaces, including the YWCA Niagara Region. The Welland Heritage Council now uses the assessment tool with newcomer and immigrant groups with great success.

This program has done very well and is growing. Partnerships expanded and strengthened with non-traditional service providers. The value of literacy assessments was enhanced enabling employment service partners to better assist their clients in realistic planning and goal-setting. And funding was secured to setup assessments via Skype, which are now provincial in scope. *

UNASSUMING WOMAN LEAVES REMARKABLE LEGACY

Olga Andrusiw's life was typical of many immigrants. Along with her husband Larry, she worked hard in her new country building a better life. Upon Larry's death a few years ago she remarked to her friend Marg Cyr that she was very appreciative of the help provided to her husband by paramedics in Niagara. So appreciative, in fact, that upon her death she bequeathed a \$530,000 gift to support education and training for paramedics.

The Foundation then worked with Niagara College and the Niagara Paramedics Association to create a fund at the College to support educational opportunities for paramedics. Olga's gift ended up leveraging an additional \$200,000 in support due to a bursary matching program that was available to the College. In the fall of 2012, the first bursaries from the Andrusiw – Niagara Paramedics Association Scholarship were given to ten paramedic students. A fund was also created at the Foundation to support in-service paramedic or first aid training.

“As a result of working with the Foundation and Sylvain Lepine of the Niagara Paramedics Association, Olga's desire to show her appreciation for the compassionate and sensitive treatment by paramedics was not only met but surpassed,” said Marg Cyr, executor of the estate. “It not only honours the paramedics, but also Olga and Larry Andrusiw, and demonstrates how a couple of even modest means can provide a remarkable gift which will benefit this and other communities in perpetuity.” *

SMITHVILLE & DISTRICT LIONS WILL ROAR FOREVER

Even though the Smithville & District Lions Club disbanded in 2012, one of the community projects it supported for many years will not be short-changed.

When the Club wrapped up its operations it had just over \$10,000 in the bank. Since the Lions were big supporters of West Lincoln Community Care, they wanted to find a way to continue their support while at the same time honour the work that the club had undertaken in its community. The solution was to turn to the Niagara Community Foundation.

At a cheque presentation on Sept. 24, former members of the Club were on hand with representatives of the food bank to make a donation of \$10,575 to the Niagara Community Foundation to create the Smithville & District Lions Club Fund, an endowment fund that will fund a grant annually to West Lincoln Community Care.

This is a positive resolution to a very difficult year for members of the Lions Club. The annual grant to the food bank will continue in perpetuity and will honour the role and contribution of the Smithville & District Lions Club to its community. *

TEACHER CREATES MUSICAL LEGACY

Carol Leppert devoted her life to teaching in Wainfleet and Port Colborne. Her love of music inspired many, some of whom went on to follow in her footsteps and become music teachers. Her students fondly remember that she never started a music class without her infamous pitch pipe.

Through a bequest, two funds have been created in Carol's name for students at Winger School and Steele Street School. The annual grant from each fund provides every student at both schools the opportunity to experience a live music or theatre performance. Each year one student from both schools will receive a bursary to the instrumental music program of the District School Board of Niagara (DSBN). Any remaining funds will be used to maintain or replace musical instruments at the two schools.

“Carol was a mentor to many teachers across Niagara, and is fondly remembered by her former colleagues, students and parents,” said Bill Mozina, president of the Education Foundation of Niagara (EFN). Carol's bequest was made to the EFN, which is working in partnership with the Niagara Community Foundation, as part of the EFN Planned Giving Program in support of DSBN Schools. CREATING LEGACIES FOR WAINFLEET AND PELHAM

2012 saw the birth of two new community funds.

With the support of the Wainfleet Township Council, the Wainfleet Community Fund, spearheaded by resident and Foundation board member, Kelly Robson, is now a reality. After presenting the concept to create a fund that would serve the Wainfleet community long into the future, council agreed and made a three-year commitment to put \$25,000 toward the launch of the fund.

The Robsons feel most fortunate to be part of such a caring community. “It’s been a great place to raise our family, because there is such a strong sense of community here,” says Kelly.

That caring spirit is something they want to nurture, provide for and contribute to. With this in mind, Kelly and Patrick opened the Robson Family Fund, Wainfleet’s first family fund. The earnings from their fund, in combination with those from the Wainfleet Community Fund, will be used to help Wainfleet continue showing the many ways it cares well into the future.

The Pelham Mayor’s Gala volunteers not only opened the Pelham Community Fund in 2012, but, thanks to the generosity of the community, raised the \$25,000 minimum in one year during the 2012 Mayor’s Gala. They plan to continue to support the Pelham Fund from future galas. In addition, as a 2012 Christmas gift to each other, Mayor Dave Augustyn and Carol Berkhout opened the Augustyn Berkhout Family Fund as the first named fund within the Pelham Community Fund. This family fund intends to create a legacy and mark the contributions that both families have made in building and improving Pelham. *

ADRIE'S HOUSE OF HOPE

In 2001, a woman lovingly called Mama Lumka, began providing hope and residential care for 16 children in her own home in Nomzamo, Somerset West, South Africa. Some of the children she cared for were disabled, some of them were HIV+ and some were AIDS orphans. All of them had been abused, neglected, abandoned and/or left by their parents. All had nowhere else to go.

Within a year, stories of Mama Lumka combing the township for neglected children and transporting them back to her home in a wheelbarrow reached the wider community. Land was purchased by the Nceduluntu Sanctuary Trust and a dream was born as foster homes were constructed on the site.

Today 32 children live in six homes on the sanctuary site, named IkhayaIthemba Village (meaning 'home of hope'). One of these homes is Adrie's House of Hope, built as a joint venture between the Rotary Clubs of Lincoln and Niagara-on-the-Lake. With the help of caring staff and many volunteers, the children are nurtured, provided with counseling, tutoring and health care.

The Rotary Club of Lincoln created the Adrie's House of Hope Fund. They remain committed to sustain this foster home and their vision is to grow the endowment to provide on-going support. ✱

LEAVING A LEGACY TO UKRAINIAN COMMUNITY

Dr. Jasoslaus Czerevko was a very caring doctor who took time with his patients and helped in many ways beyond providing medical assistance. He was that rare breed of doctor who still made house calls late into the night.

He was born in the Ukraine in 1921, studied medicine in Austria and came to Canada in 1948 to complete his internship and residency. Dr. Czerevko opened his practice in Niagara-on-the-Lake in the mid-50s. He closed his practice there in the early 1970s and subsequently opened a new practice in Fort Erie around 1972, finally retiring in September, 1991.

During his lifetime, the doctor supported a number of Ukrainian organizations. Through his estate, a gift of \$5.8 million was donated to the Foundation to establish the Dr. Jasoslaus and Mrs. Edith Czerevko Family Fund. With this gift, the capital is held in an endowment with the annual distribution supporting five Ukrainian-related charities:

- Ukrainian Canadian Congress Charitable and Educational Trust for programs serving Niagara
- Sts. Cyril & Methodius Church in St. Catharines
- Nativity of the Holy Mother of God Ukrainian Catholic Church in Niagara Falls
- St. John the Theologian Ukrainian Catholic Church in St. Catharines
- Ukrainian Canadian Social Services

Dr. Czerevko's gift has created a wonderful legacy in support of organizations important to him and his community. ✱

ENDOWMENT FUNDS CONTINUE TO GROW

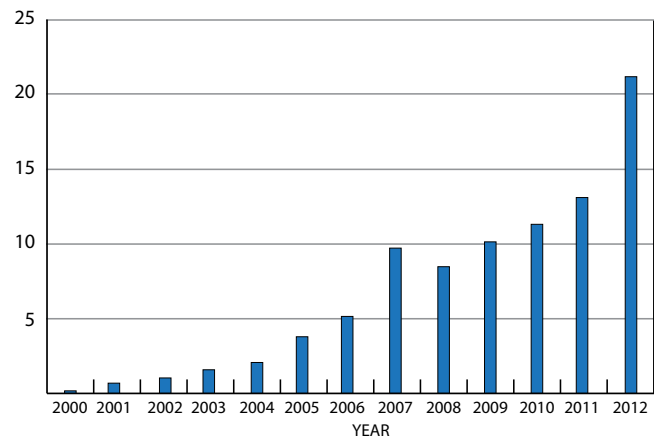
The Foundation has a different face to each of our donors. Their funds can support a particular cause, community or charity and once a fund is opened anyone can make gifts of any amount, in any way, at any time. Donations can also be made in honour or memory of a loved one.

There are many ways to make a gift to the Foundation. These include cash, securities, bequests, special event proceeds, property, and insurance policies. Our role is to work with donors to ensure that their charitable intent is achieved through their gift.

There are a number of options for donors when considering how long they would like their fund to be active. Most of our funds are held in perpetuity, where the capital is preserved and a portion of the annual earnings on the fund are allocated to charities. Funds can also be held for a specific length of time or established to have a fixed annual distribution. In these later two examples both the capital and the earnings are distributed.

However, with increasing demands for support, it is important to take the time to determine how to make 'the best gift', a gift that provides maximum benefits to the community that is within one's capacity to give. We strongly advise donors to speak to their family, lawyer, accountant or financial planner to determine the best way to make a gift that maximizes their tax and estate goals.

SMART AND CARING COMMUNITY FUNDS

Governor General David Johnson became the patron of Community Foundations of Canada in 2011. His vision to build smart and caring communities is based on three pillars: innovation, philanthropy and volunteerism. His vision meshes with our guiding principle to demonstrate philanthropic leadership. In recognition of his vision, we have renamed our unrestricted and community funds as our Smart and Caring Community Funds. These funds give the Foundation the greatest flexibility to respond to current community needs by providing grants to charities across Niagara. Applications are assessed by a group of volunteers based on specific criteria that are determined regularly by the board of directors.

Our current funding priorities include: initiatives that align with priorities identified in the Living in Niagara Report, resources to help charities become more efficient and effective,

projects to help children and youth thrive, and leadership development and training opportunities for the voluntary sector. Donors interested in supporting future community needs are able to make a contribution to the Niagara Fund or one of the local community funds listed below. Grants from community funds are restricted to charities providing programs and services in those municipalities.

Donors can create a named fund within any of our community funds with a gift of \$5,000, which can be gifted either on an annual or monthly basis over a 5 year period.

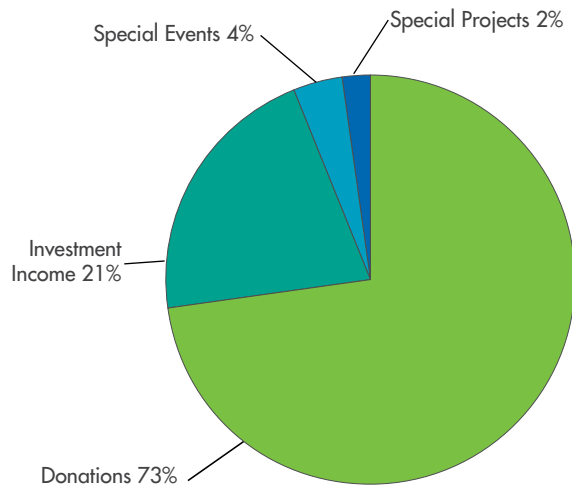

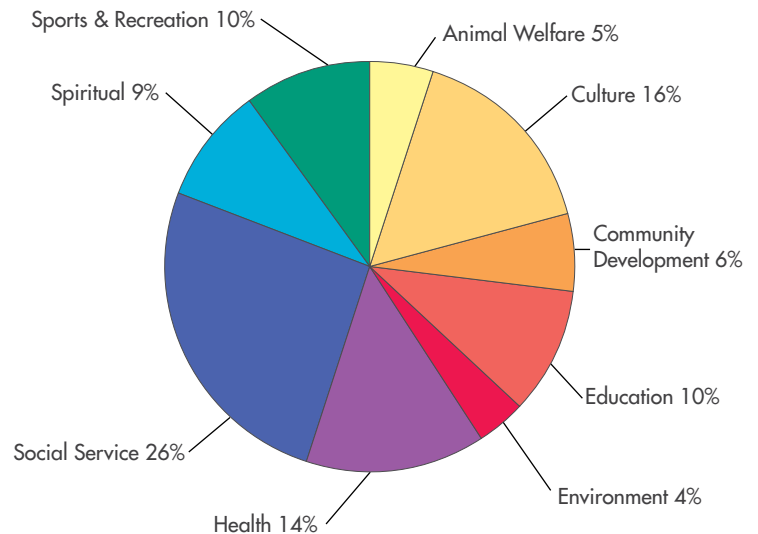
SOURCE OF REVENUE

FINANCIAL AND GOVERNANCE HIGHLIGHTS

GOVERNANCE

The Board's role is to set policy and to question, scrutinize and monitor the management of the Foundation's affairs. It is a role of governance as opposed to operational management. The Board's primary responsibility is to build and ensure sound management of the Foundation. It oversees the Foundation's management and ensures that the affairs of the Foundation are being conducted in a manner that achieves its goals, consistent with the Foundation's mission. The Board meets five times throughout the year plus a special meeting for strategic planning. The Role of Board and Executive and the Scope of Authority policies are in place to delineate responsibility between board and staff. The Board has also adopted a Code of Ethics and Confidentiality policy for board, staff and volunteers.

OPERATIONS

The Foundation's staff is led by the Executive Director, who reports to an independent board of directors. Operating costs include asset development, charitable activities, special projects, administration and governance. The Foundation also received funding in 2012 from Niagara Region to support the position of Convenor for the Niagara Prosperity Initiative. This funding enables us to bring community groups together to guide poverty reduction initiatives. We also hosted the activities of Niagara Connects (formerly the Niagara Research and Planning Council) which, among other initiatives, produced the 2011 Living in Niagara Report. The recommendations in this report enable the Foundation to ensure that our discretionary grant programs address community priorities.

Fund development, administration and governance expenses for the fiscal year ended December 31, 2012 totaled \$518,727. The expense of development activities is not necessarily related to the donations received in any one year and gift delays result in

costs preceding the receipt of gifts by several years (for example, gifts in wills and life insurance). As a result, consistent with the community foundation sector, operating costs are evaluated by a ratio of total operating expenses to average total assets. For 2012, that percentage was 2.5%, within the range of community foundations of similar size and stage of development. Each endowment fund is charged a pro-rated administration fee of up to 1 per cent which helps to offset these expenses.

INVESTMENT FEES AND RETURNS

The Foundation's investments are pooled with a number of other public foundations and charities in an investment pool with the Toronto Community Foundation. This relationship has been in place since 2001 and is re-evaluated on a regular basis by the Investment Committee.

The endowments are invested according to the investment policy guidelines established by Foundation's board and are available at www.niagaracommunityfoundation.org. All portfolios are managed by professional investment managers and in accordance with the policy.

The average investment fee paid for 2012 was 0.62 per cent. This fee is charged to each fund on a pro-rated basis. Investments returned 12.17 per cent in 2012 compared to market index of 7.34 per cent. The 3-year annualized return was 6.96 per cent.

FINANCIAL AND GOVERNANCE HIGHLIGHTS CONTINUED

In November, the board of the Foundation made a commitment to invest \$500,000 in the Community Forward Fund, a social finance investment fund. The returns for this investment will be reflected in the 2013 report.

RISK MANAGEMENT

The Board has a comprehensive risk management policy covering legislative and legal, fiscal performance, financial reporting, management of volunteers, effective management and governance, economic risk, and donor and volunteer stewardship. The Finance Committee annually reviews the Foundation's exposure to risk and mitigants to address perceived or actual risks. The Board regularly considers risk exposure as part of its deliberations. The price risk related to investments arises due to fluctuations as a result of changes in market prices whether those changes are caused by factors specific to the individual security or its issuer or factors affecting all securities traded in the market. Accordingly, the Foundation is exposed to the effects of the market fluctuations.

ACCREDITATION

In 2012, the Foundation received accreditation through Imagine Canada's Standards Program. The Foundation was one of the first community foundations accredited in Canada. The program offers a Canada-wide set of shared standards for charities and nonprofits wishing to enhance their effectiveness in the fundamentals of governance, paid-staff management, financial accountability, fundraising and volunteer management. The program includes a voluntary accreditation program for organizations wishing to publicly demonstrate they have successfully met the standards through a third-party peer review process.

EVALUATION

The Board has adopted a comprehensive annual process to evaluate its performance. The results of the evaluation are reviewed at its November meeting where actions to improve board performance are implemented. This process is done on a biennial basis with Foundation committees. Employees of the

Foundation participate in annual performance appraisals, which include on-going review throughout the year. The Executive Director's review is presented annually to the Board by the Board Chair.

COMPENSATION

The Board has established salary ranges for each of the Foundation employees. The ranges are determined based on reviewing similar positions within the community foundation sector across Canada as well as similar positions within Niagara. Ranges are adjusted regularly to reflect cost of living changes. Movement through the range is dependent on performance. For 2012, the Executive Director received a salary of \$84,703 plus 8 per cent benefits.

BOARD RECRUITMENT, ORIENTATION AND TRAINING

The Bylaws of the Foundation set out the Board recruitment process. Members of the Nominating Committee are selected by virtue of office and include the Immediate Past Chairman of the Foundation Board, Niagara Regional Chair, the President or designate of the United Way of St. Catharines and District, Niagara Falls and Greater Fort Erie, and South Niagara, a local Judge of the Superior Court of Justice of the Judicial Districts of Niagara North or South, the President of Brock University or the President of Niagara College. Nominees from across Niagara are identified based on current board attributes and future strategic needs. The Board is comprised of 17 members who are elected for a three-year term, which can be renewed once. The term can be extended if a director is serving as the vice-chair, chair or past-chair.

New directors take part in a formal orientation program. Board training takes place at each meeting and additional opportunities are provided throughout the year for members to participate in professional development provided by Community Foundations of Canada.
