a time FOR REFLECTION




There comes a time in every organization's life cycle for reflection on its impact and place in the community. The foundation started its process of reflection in 2006.

great grants RESTORE WETLANDS promote culture



Many of us take for granted our ability to use the telephone. If we can't quite hear when we're on the line, we ask the person on the other end to speak up a bit or we turn up the volume. However, for many in our community these two solutions don't work.

With its \$1,196 grant from the foundation, Information Niagara purchased a TTY machine. A TTY, or teletypewriter for the deaf, is a device that lets people who are deaf, deafened or hard of hearing use the telephone to communicate, by allowing them to type messages back and forth to one another instead of talking and listening. One of the agency's standards relates to providing barrier free access to service for individuals and groups who have special needs. The use of the TTY machine is the acceptable method of providing this service.

Information Niagara provides information, referral and interpreting services to the people and communities of Niagara through the assessment, collection, maintenance and dissemination of human services information.

This agency annually processes up to 29,000 requests for information and referral. Its newest service is 211, which operates 24/7 helping people find solutions to problems by providing information or by referring them to the appropriate services in the community.

This grant, from the foundation's Community Grants Program, is a wonderful example of the impact that a small investment can have on a group of individuals and on an agency's capacity to deliver services. Wetland Restoration

The Welland River watershed is the largest and most stressed waterway within the jurisdiction of the Niagara Peninsula Conservation Authority. A Welland River Watershed Strategy was developed with one priority being the need to increase and re-establish habitat density and diversity within the watershed. Wetlands are critically important in terms of water quality









and habitat restoration. They filter pollutants, reduce erosion and flooding and provide shade and food for fish and other aquatic species.

The E. C. Brown Wetland Restoration site was identified as a high priority area for restoration. Its \$2,500 grant from the foundation will be used towards the restoration costs, which are estimated to be about \$160,000. Other funding agencies are providing the additional resources to complete this project, along with the 'sweat equity' of the volunteers of the Welland River Keepers, Niagara Restoration Council and local schools.

This project will provide an excellent wetland restoration demonstration site. Different restoration and ecology principles will be showcased illustrating techniques for restoring and re-establishing wetland, riparian buffers, and naturalized areas. The linkage to the existing conservation area makes it an ideal location to broaden the recreational potential of the park and its day use activities. An interpretive boardwalk will be incorporated into plans for the site, with a series of signs explaining the different eco-zones.

This grant was awarded from the foundation's Environmental Grants Program. Further information about the program's grant criteria can be found on the foundation's website.

Summer Music Camp Family

Summer camp is a wonderful opportunity for children to learn new skills, meet new friends and have a lot of fun. In 2006, the foundation in partnership with many donors and the Osprey Media Niagara Publishing Group, provided \$18,100 in grants to send more than 225 children to camps across Niagara.

The Niagara Symphony Summer Music Camp was one of the beneficiaries. Its grant helped three children attend camp. Two of the children are sisters who are being raised along with two other siblings by their grandmother, who walked the girls to Ridley College every day from their home near a local factory. Both girls enrolled in beginner violin. The eldest was immediately absorbed by the instrument and is now enrolled in the school violin program with hopes to become a violinist.

Her sister was not particularly enthralled with violin, but she did what she was asked and each day showed the camp's educational co-ordinator what she had learned. They then would tour the camp classes and discuss camp, music and life in general. On their walkabouts it was discovered that her true interest was percussion. This interest was cemented when she heard PK Hummingbird Steel Drum Band at a morning recital. This particular drum band encourages young people and trains them for free. So now the reluctant violinist is playing steel drums year round and having a great time. Incidentally, she made her sister go with her to drum band so now both girls have experience on two instruments.

These experiences would not have been possible without the support of the Osprey Media Niagara Publishing Group Summer Camp Fund. Since its launch in 2002, almost 700 children from across Niagara have been helped to attend camp.

Bike Program For Youth

Kids and bikes go hand-in-hand like peanut butter and jam. Cycling is a great way to get around and one can go to places much faster than using one's own two feet. Community Living Port Colborne –Wainfleet received a \$4,000 grant to assist with the costs for a new youth recycling and bicycle program. The goal of the program is to give youth at risk new skills and do something positive for the community. Community Living also believed that building or rebuilding bikes builds confidence. There was no charge for the program and once the young person successfully completed the program, they earned a rebuilt bike for themselves. This was a wonderful bonus, as some participants were from single parent families facing financial challenges.

Most of the young people who participated attended a special education program through one of the local school boards. And at times the program goals were altered when a lesson on fixing a flat tire turned into a lesson on how to speak appropriately to an employer.

This grant was one of nine grants ranging from \$1,000 to \$7,000 awarded from our Youth Grants Program, the funding for which is provided to the Niagara Community Foundation by the Branscombe Family Foundation.

CREATING MULTIPLE LEGACIES

Andrea Kriluck is one of the first officers of the foundation, signing the articles of incorporation in 1999. Since that time she has served as our Treasurer, President and at the annual general meeting in 2006 became our Past-President.

At that AGM, Andrea announced a gift from her and husband Marv Kriluck to create the Andrea & Marv Kriluck Fund. This fund is one of the group of funds within our Niagara Fund, an unrestricted pool of capital, the earnings from which will support projects across the region long into the future.

"I have been a part of the foundation since the first community meeting held in March 1999," said Andrea, "and since that time have come to realize that the gifts to the Niagara Fund will give the foundation the greatest flexibility. Who knows what will be the needs of the community 20, 30 or even 100 years from now? Both Marv and I are confident that our gift will be used wisely by future boards for the betterment of the community."

Later in 2006, Andrea created a second fund at the foundation, the Schizophrenia Research Fund. The proceeds from this fund will support research into the cause, treatment and cure of schizophrenia undertaken by the Canadian Psychiatric Research Foundation. Andrea wanted to create this fund to provide lasting support for schizophrenia research. This is an open fund, meaning that others who also support its purpose can add their donations to the fund. Andrea is now meeting with the staff of the Canadian Psychiatric Research Foundation to develop and implement plans to promote the fund nationally.

SLEEP CHEAP CHARITIES REAP

During the past three years, the hotels in Niagara Falls offered 4,000 rooms during the last week in November at incredibly low prices – anywhere from \$25 to \$45 per night.

This promotion, called Sleep Cheap, raised \$125,000 in 2006 for local charities. Half of the

proceeds were gifted to the foundation to create the Niagara Falls Community Fund.

Three of the hotels allocated their share of the proceeds to the foundation to create named funds: the Embassy Suites Hotel – Niagara Falls Fallsview Fund, the Hilton Niagara Falls Fallsview Fund and the Niagara Falls Marriott



Hotels Fund. These three funds are now part of the family of funds within the Niagara Falls Community Fund, which supports programs and services in Niagara Falls.

Since the Sleep Cheap event two of these new funds have seen additional activity. Embassy Suites held a wonderful Christmas party for family, friends, employees and associates and, in lieu of gifts, asked that donations be made to the fund. And somebody at the Marriott, but we won't say who, turned 40 early in 2007 and asked that donations be made to their fund.

What a great beginning to creating this legacy for Niagara Falls. Thanks to Alderman Jim Diodati for his leadership in organizing the event and to Mayor Ted Salci and CAO John MacDonald for their encouragement to have the fund launched in 2006. And thank you to the owners of Embassy Suites and the Marriott Hotels for their additional support.

TRADE ASSOCIATION CREATES ENVIRONMENTAL FUND

Donations to the foundation come from many sources – individuals, companies, foundations, schools, special events and employee associations. In 2006, we received a gift from a provincial trade association. This is not the first time we have received such a gift.

In 2003, the Professional Engineers Association of Ontario, Niagara Chapter created the Niagara Engineering Week Scholarship Fund. And in 2002, the Niagara Road Supervisors Association created a fund.

During the summer of 2006, foundation board member Eric Gilbert encouraged his trade association, the Ontario Tire Dealers Association, to have its annual golf tournament in Niagara. This tournament was always a charity event, with the local host providing guidance in selecting the beneficiary.

As the host, Eric took a leadership role in working with the association board members to use half of the proceeds to create the Environmental Legacy Fund for Niagara West. Creating an endowment fund was a first for this group. The association also made a commitment to return to Niagara in a few years and again direct the funds raised to this new environmental fund.

With the other half of the proceeds, the foundation supported two projects. The volunteers with the Grimsby Conservation Club received a grant to create a new fish hatchery. We also supported the Children's Water Festival taking place in September 2007 at Ball's Falls. Thank you to the foresight of Eric and the members of the Ontario Tire Dealers Association for their gift to Niagara West.

UPPER CANADA LODGE AUXII IARY

One type of fund growing in popularity is a charitable organization fund. This fund is created by and for a local charity and each year an unrestricted grant from the proceeds on its fund is given back to the charity. These types of grants are very beneficial as they can be used to support the organization's core operating costs, funding for which is often difficult to obtain. The foundation now has 11 charities that have established a fund to support their programs and services.

The Upper Canada Lodge Auxiliary supports Upper Canada Lodge, a home for seniors in Niagara-on-the-Lake that is owned and operated by the Regional Municipality of Niagara. Over the years, the Auxiliary which is run by volunteers, has provided funds to the lodge to purchase equipment and other resources through a variety of fundraising activities.

Last year, the Auxiliary received a significant bequest and faced the dilemma of whether to allocate it all to the lodge for immediate equipment needs or to create an endowment fund and allocate the earnings each year to the lodge. The volunteers were also experiencing another worrying trend, specifically the strain on their resources to operate their on-going fundraising activities.

After much thoughtful discussion, the decision was made to allocate 100% of the bequest to create the Upper Canada Lodge Auxiliary – Constable Family Fund, named after the deceased's family. This proved to be the right decision because no sooner was the fund created than a gift in memory of a former resident of the lodge was added to the fund. The earnings could replace funds generated from other fundraising activities, thereby addressing the issue of strained resources. What a great solution for the auxiliary with multiple benefits!

VOLUNTEERS

are key to our success



Volunteers are the lifeblood of organizations like ours. They provide direction on the goals of the foundation, give support for our many initiatives across Niagara, provide their technical expertise and lend an extra pair of hands when needed.

A board of 17 men and women from across the region governs the foundation, the list of which can be found on page 22. Many have been with us since our early days. However, board members have a limit on their term of office and over the next few years we will be saying thank you to our founding directors who will be completing their term and welcoming our new members.

Pat Darte, Sean Jackson, Rob Neil and John Palumbo finished their terms in 2006. Each contributed to the work of the foundation in a different way. Pat was on the Steering Committee, signed our original Letters Patent, served as board secretary and helped to raise the profile of the foundation in Niagara-on-the-Lake. We were honoured at our launch in 2000 that Sean Jackson, CEO of Niagara Credit Union, which has since merged to become Meridian Credit Union, presented the credit union's \$100,000 gift, one of our first endowed gifts.

Ever enthusiastic Rob Neill provided technical assistance and strategic guidance and facilitated the first gift to the St. Catharines Community Fund, creating the Durward Jones Barkwell LLP Fund. John Palumbo linked us to both the Niagara Falls and Fort Erie communities finding opportunities for us to promote the foundation in a variety of ways.

While they may have left the board, they have all agreed to become members of our Ambassador's Circle. Made up of former members of our board, the Circle members agree to act as a resource, identify opportunities, open doors and, where possible, represent the Foundation at public events.

And the best part about being an ambassador is that members don't need to come to any more meetings! Joining John, Pat, Rob and Sean will be former board members Shirley Martin and Eugene Oatley.

Thank you to all our ambassador's for their work while on the board and for continuing to passionately support our work helping good people do great things in Niagara.

ENDOWMENT FUNDS continue to grow

The foundation's endowment grew to \$5.1 million in 2006, a 28% increase over last year. The Foundation has a different face to each of our donors. We are finding that their gifts support a particular cause or fund or is given in honour or memory of an individual. Our role is to work with donors to insure that their charitable intent is achieved through their gift. Thank you to those who chose to leave their legacy to the community through the Niagara Community Foundation. There are many ways to make a gift to the foundation including cash, bequests, insurance policies, securities or property.

However, with increasing demands for support, it is important to take the time to determine how to make "the best gift", a gift that provides maximum benefit to the community that is within one's capacity to give.

In order to determine how to make "the best gift" consider these factors:

- Financial circumstances (i.e. financial resources and obligations)
- Personal circumstances
- Philanthropic objectives, such as:
 Interest in a particular field of interest (i.e. arts, education, children and youth, seniors, the environment);

 Provision of immediate or ongoing support;
 Assurance of wise investment of your gift (regarding both investments and grants).

We strongly advise that you speak with your lawyer, accountant or estate planner to determine the best way to make a gift that maximizes your tax and estate goals. We also suggest that you speak to your family should you decide to leave a bequest.

The foundation provides a variety of endowment fund options for donors to consider. Funds can be created during your lifetime or through your estate. Donations to create named funds can be gifted over a ten-year period.

As you imagine the possibilities for leaving your legacy, read through the options available to our donors. The foundation staff would be pleased to meet with you to help explore how best to fulfill your charitable intentions.

A donation to the Niagara Fund gives the foundation the greatest flexibility. The earnings on this fund enable our board of directors to respond to current community needs through the provision of grants to charities throughout Niagara. Donors interested in supporting future community needs are able to make a contribution of any size to the Niagara Fund. Donors can establish a named fund within our Niagara Fund with a \$5,000 gift.
