Executive Message

The global pandemic continued to upend all our lives throughout this past year. But as much as 2021 provided its fair share of challenges, at the same time opportunities for growth on a multitude of levels revealed themselves. As an organization, our collective intention and effort as mentioned in the quote has galvanized our resolve to rise to these challenges and to embrace the opportunities for the benefit of the entire community.

As a community foundation, NCF knows the strengths and the needs of our region and we translate this knowledge into strategies that influence and inspire our fundholders, donors, key stakeholders and charity partners to act. We strive to work collaboratively in our community to pursue equity and deliver support for those who face the greatest challenges. And when crisis may arise, we swiftly convene with our partners to efficiently and effectively deploy resources to those most in need.

2021 saw the Foundation make grants of \$2.7 million dollars. This noteworthy amount brings our historical tally to over \$21 million dollars to charitable organizations from Grimsby to Fort Erie and each municipality in between since our inception in 2000. Beyond the financial figures, the stories of some of our grant recipients that start on page 5 are truly inspiring.

Our ability to support so many worthy and deserving local causes and charitable projects is due to the tremendous generosity of our fundholders and donors. The depth and breadth of our donor directed grants may be found on page 19 and are highlighted through our named funds starting on page 25.

This past year we were able to realize the fourth grant dispersal from the David S. Howes Fund with 21 grant requests totaling \$1.7 million dollars. After rigorous review and consultation, NCF's Directors approved 11 projects representing \$700,000 of funding. In just three short years, an extraordinary \$2.3 million has been injected into the community's charitable sector through this transformational Fund.

When the Foundation's Annual General Meeting rolls around in May of 2022, David Shaw (Fort Erie) and long serving chair of our Investment Committee Mario Ferrara (NOTL) – who generously extended his term allowing us to find a new committee chair – will complete their terms as directors. Technically they have given a combined 14 years of service. However, their true contributions to our organization and the community at large far exceed this metric. We are truly grateful

HIGHLIGHTS

Priorities, Strategies, and Plans

2021 had continued challenges for our community, our country and beyond. The Foundation was determined to continue to do our part to support the charitable sector in Niagara in response to the ongoing pandemic. Here are some of highlights of the Foundation's impact in the region:

- In total, awarded \$2.7 million in grants bringing historical granted total to \$21 million+;
- Disbursements from the David S. Howes Fund to 11 Niagara projects representing valued at just shy of \$700,000 of grant funding;
- Approved 18 new named endowment Funds increasing total assets to over \$76.5 million.
- Creation of a new Marketing & Communications strategic plan with Armstrong Strategy Group (ASG).
- Engaged in a partnership with Hughes & Co. (www.hughesandco.ca) – local Marketing firm to refresh the NCF brand and develop a vibrant marketing plan.
- Continued partnerships with two Social Impact Investment (SII) groups: Community Forward Fund and the Fair Finance Fund;
- Procurement and integration of a new cloud-based CRM database software: CommunitySuite by Foundant Technologies;
- Launch of the Unflood Ontario awareness campaign in May 2021;
- Four Strategic Initiatives Grants awarded in support of both Niagara's Indigenous and Black communities including: Niagara Chapter – Native Women Inc., the Niagara Region Native Centre, TOES Niagara and Future Black Female.

We realize that collaborative partnerships with funders and other organizations will go a long way toward ensuring that our grant recipients, their clients and our donors receive quality service and support from the Foundation. Here are some examples of how the Foundation has continued our partnerships in 2021:

GREAT LAKES ONE WATER (GLOW) INITIATIVE: UNFLOOD ONTARIO

Lead by the Small Change fund, NCF along with the Toronto Foundation and the Durham Community Foundation launched Unflood Ontario in the spring of 2021; an educational and engagement campaign to learn about natural infrastructure and the positive impacts it can have to mitigate the impacts of flooding. Garnering support from all 13 community foundations around the Golden Horseshoe along with over 40 stakeholder, Unflood Ontario successfully built a network of support for natural infrastructure in our communities.

NIAGARA PROSPERITY INITIATIVE

The Niagara Prosperity Initiative (NPI), funded by Niagara Region, is a partnership of public, private and voluntary organizations working to reduce poverty in Niagara. In 2021, funding was renewed to NCF to continue to support one Convener position. Staff from the Foundation also assisted with the review of the grant applications for \$1.5 million in NPI funding.

NIAGARA CONNECTS

The Foundation has been a partner with Niagara Connects since the organization's inception. This network brings people together to gather, share and learn from data, to support evidence-informed action planning for a stronger future. The Foundation continues to utilize the priorities highlighted in Niagara Connects' triennial Living In Niagara quality of life report. This report continues to be an instrumental tool used by governments, businesses, charitable organizations and non-profit agencies to identify emerging issues and opportunities in Niagara.

GOVERNANCE COACHING PROGRAM (GCP)

A product of our Centre of Excellence, NCF has launched the revised Governance Coaching Program (GCP). Five charities were selected to work with a GCP consultant to improve selected priorities areas of their organizations including: board leadership, oversight, policies and processes, financial accountability and transparency, fundraising strategy and donor relationships, staff management and volunteer involvement. The organizations selected in 2021 include: Community Care of West Niagara, Future Black Female, Heart Niagara, Niagara Symphony Orchestra and the Welland Heritage Council. NCF continues to be committed to strengthening the charitable sector and the GCP program is one way we hope to have an impact.



COMMUNITY GRANT

Niagara Children's Centre

Sabrina Elliott Vergara knows the loneliness of learning your child has special needs.

That's why she is grateful for a \$13,000 grant from the Niagara Community Foundation that has allowed the Niagara Children's Centre to establish a mentoring program for parents of children with physical, developmental, and communicative delays or disabilities.

Elliott Vergara's son, Alexander, was born prematurely and came home from the hospital after months in the neo-natal intensive care unit to a life of multiple medical appointments and extreme vulnerability. For the new mother, the trauma and isolation were overwhelming.


"I never want someone else to feel so isolated and completely alone," said Elliott Vergara, a member of the Centre's family advisory network who now manages the new family mentorship program. Elliott Vergara recruits and trains parents so they can support other families.

Elliott Vergara says it takes someone with lived experience of being a caregiver for a child with special needs to understand the journey other parents or caregivers are on. No matter how caring your friends and family are "no one knows what it is like until they experience it," she said. "It's not about the mentors having answers, it's about connection."

Meet the organizations who received the grants and made a difference in the community.



In addition to the programs and services the Centre offers children and their families, the mentoring program is a way to support families who can be under tremendous stress.

"We want to be the village around them," said Elliott Vergara, "to complete the circle of care the Centre is able to offer." Stronger families have a ripple effect in the community, she said, because other family members also function better and because empowered parents are better able to support their children in the health care system.

In the first year of the program, 13 mentors were recruited and trained, and 32 families were paired with an understanding, listening ear.

The program will continue, said Elliott Vergara, because the feedback was overwhelmingly positive. "This program has helped me so much emotionally," wrote one parent. "At times I felt alone, but having a mentor who understands has made this journey so much better."

DAVID S. HOWES FUND GRANT

Niagara Health Foundation

Niagara Health's St. Catharines Site has never had an outbreak of any airborne illness.

The hospital, which opened in 2013, was designed and built after the 2003 SARS pandemic, so attention was given to managing airflow and ensuring the same air, breathed by someone with a severe contagious illness, wasn't circulated throughout the rest of the building.

Two portable air scrubbers, purchased by the Niagara Health Foundation with a grant of more than \$37,400 from the David S. Howes Fund, helped ensure the hospital's track record during the COVID-19 pandemic. The units, each the size of a foot stool, could be moved from room to room, even hospital to hospital within the Niagara Health system, to help patients and staff breathe easier by living up to their name.

They cleared the air of the potentially deadly COVID-19 virus from rooms where an infected person recovered in isolation from surgery or dealt with another medical issue. And they came in particularly handy during the worst of the Omicron variant when infections skyrocketed.

“It's good for the patient and good for staff, and really good for the other patients because you're protecting them from airborne viruses,” said Pamela Shanks, Niagara Health Foundation vice-president of development.

The scrubbers were among a list of equipment the health system needed, including additional beds and ventilators, during the height of the pandemic. Once the pandemic is history, however, they will continue to be used to keep people safe and healthy while in hospital, including against flu strains.

“The Niagara Community Foundation grant was a huge benefit,” Shanks said. “(The scrubbers) were critical to the fight against COVID-19. We're still using them and we'll use them going forward.”

SUMMER CAMP GRANT

Niagara Pumphouse

Magic happens when a paintbrush is put to canvas.

For five Niagara children, that magic was in more than the art they created during weeklong summer camp sessions hosted by the Pumphouse Arts Centre in Niagara-on-the-Lake last year. It was also in the memories they made — memories made possible by a Summer Camp Mini Grant from the Niagara Community Foundation.

The \$1,000 gift to the Pumphouse covered the camp costs for those children, aged five to 12, and gave them the chance to paint, sculpt, make prints and other mixed media work inspired by other artists. They also got to try their hands at plein air painting — the muse of so many European masters — on the Pumphouse grounds overlooking the Niagara River, and then show off their work at the end of the week in an exhibition that celebrated their efforts.

Mostly, they got to be kids during a time that fun forgot with the COVID-19 pandemic.

“We believe in the therapeutic benefit to art-making, especially in these difficult times,” said Rima Boles, Niagara Pumphouse director. “There's a lot of stress on kids. Participating in creative activities, creating visual art and focusing on creative activities can help in these stressful times.”

One participant discovered he loved painting. Two others, who arrived to Canada two years ago from Syria via Lebanon, got to spend time with other children in their community. The siblings hadn't been able to attend school in Lebanon and then arrived here just as the pandemic and lockdown living started.

Their only exposure to other children was virtual, during online learning for school. That made an in-person summer camp experience even more special, Boles said.

COMMUNITY GRANT

Project SHARE

It's been said that if you have a garden and a library, you have everything you need.

If Jo Low, operations manager at Project Share in Niagara Falls, were to edit that quote, it might read, 'If you have 170 gardens and a garden co-ordinator, you have everything you need.'

All those gardens, part of Project Share's community garden network spread over three sites in the Cataract City, were the impetus for the food bank applying for a \$15,000 Community Grant from the Niagara Community Foundation last year. Low, who served as the garden co-ordinator previously, needed help overseeing the plots and the people renting or borrowing them to grow their own produce and become more food secure, which is a large part of Project Share's mission.

Money from the community foundation enabled Project Share to hire a student from the Niagara Parks School of Horticulture to help with everything from troubleshooting for gardeners and co-ordinating volunteers, to hosting workshops that turn regular thumbs into the greenest of thumbs.

An additional grant from elsewhere meant Project Share could double up on the help and harvest more than 1,500 pounds of food for its own services throughout the season.

Equally as important, especially with the uncertainty caused by the pandemic, 170 individuals and families could reap the benefits of getting their hands dirty, getting outside, and growing an average 150 pounds of food each to nourish body and soul.

"The garden was in good hands with the girls we hired," Low said. "We learned that during a pandemic, community gardens are even more important to people in terms of their mental health, sense of community, food security, and general well-being."

MINI GRANT

St. Catharines Public Library

Books aren't the only mind-growing things on loan at the St. Catharines Public Library these days.

Thanks to a mini-grant from the Niagara Community Foundation, library patrons can explore the universe beyond the printed page, by checking out a backyard telescope.

Adding the amateur astronomy kits to the library's collection was a way for the library to offer patrons safe, outdoor ways to learn, said collections librarian Jake Anderson. The telescopes have become "one of the most successful items" in the library's non-traditional collection, which includes things like board games, fishing rods, or outdoor sports equipment. The idea came when Anderson and a colleague were brainstorming additional ways to serve patrons that would be pandemic-safe, family friendly, and both get people into the library and get them outside. "It's the perfect educational tool," he said.

The library started by purchasing three telescopes "but they exploded in popularity," Anderson said. As the hold list grew and grew, the library bought seven more, and they still can't keep up with demand. At any given time, there are 60 to 100 holds – people who are waiting to be notified a telescope, with instructions and amateur astronomy book, are available to them on a one-week loan. Other libraries are copying the idea and there is no sign the telescopes are waning in popularity.

The Niagara Community Foundation grant, which helped cover the cost of the first three telescopes, was an important catalyst to the success of the initiative. Subsequent purchases have been funded from the library's budget, but the grant allowed Anderson to prove the telescopes' viability. "The grant was absolutely crucial for us to be able to pilot them," he said. Without the starter funding, "I don't think we would have tried the program."



STRATEGIC GRANT

FACS & Future Black Female

Young Black women in Niagara received some extra encouragement to stay in school and stay strong last year, as the COVID-19 pandemic added extra stress to their lives.

A \$20,000 grant from the Niagara Community Foundation enabled Future Black Female and Family Counselling Centre of Niagara to support eight young Black women with mental health counselling, financial literacy workshops, one-on-one mentoring, and career guidance and coaching.

The teenagers and youth, ranging in age from 16 to 22, had either dropped out of school or were at risk for dropping out. The goal of the pilot program was to equip the young women to map out a path to higher education or employment by helping them gain control over specific areas of their lives. As a result of participating in the program, several found work to support their goals, one started a business, and most are gaining additional skills by volunteering at local organizations.

The pilot program showed that the potential of these young woman was often at risk because of the lack of culturally relevant support, said Tapo Chimbanga, founder and executive director of Future Black Female. The young women said they faced considerable barriers to success, and they identified their number one source of stress as not knowing what to do after high school. They either didn't talk to high school guidance counsellors or, when they did, felt their dreams were crushed or abilities minimized.

As a result, Future Black Female will strengthen its career guidance and coaching initiatives, Chimbanga said, and work with partner agencies, such as college and university admissions offices, children's aid societies, and apprenticeship programs, to increase awareness and reduce barriers. "By providing culturally relevant and responsive guidance counselling, more Black girls and women can make informed decisions and start off on a strong foundation. Black women will have access to knowledge and information that can help them make better decisions for their economic security and prosperity."

STRATEGIC GRANT

Tools of Empowerment for Success Niagara

Black teenagers in Niagara are learning self-advocacy and getting a boost to their confidence because of a grant that gives them access to new skills and connections with mentors and role models who look like them.

A partnership with Brock University and a \$25,000 contribution from the Niagara Community Foundation allowed Tools of Empowerment for Success (TOES) Niagara to develop a year-long education program to empower Black teenagers to take charge of their futures.

From Saturday morning lessons on campus at Brock University to field trips to Queen's Park and Black history sites, about 60 Niagara teens were shown how to participate in government, how to celebrate their identities, and the steps they can take to reach their full potential. They learned anti-racism strategies, financial literacy, how to take care of their mental health, and how to explore the careers open to them.

Nyarayi Kapisavanhu of TOES Niagara said holding the classes on campus at Brock was a way to make participants comfortable with a university environment and be able to imagine themselves there as students one day.

Parents were also invited to participate in a parents' program, and students were paired with a Black mentor who got to know them and encouraged them in their hopes and dreams.

The pilot project, which had space for 60 students from the Niagara Catholic District School Board, ended up with a waiting list, said Kapisavanhu, but its value is clear and the program will be expanded into other school boards.

"Niagara Catholic recognizes the very specific needs of addressing the challenges of Black youth in our schools, specifically in finding mentors who represent their future selves," said Lee Ann Forsyth-Sells, Niagara Catholic Superintendent of Education responsible for the Equity and Inclusive Education portfolio. "We are very pleased to partner with TOES Niagara in creating this program, and thank the Niagara Community Foundation for the funding to support this innovative project.

One parent who attended the parents' course said she learned about governance and was inspired to join the parent council at her child's school. For a student participant in a school with only three black students and an all-white staff, being in a room full of other teenagers who could share her cultural experience was a comfort. It was also a relief to be paired with a mentor "who looked like me to guide me in my future plans," she said. "Even if I feel alone at my school, I am not alone because [this program] has provided a village for me."

ENVIRONMENTAL GRANT

Trout Unlimited

When it comes to gauging the health of the environment, Niagara's canary in the coal mine is the brook trout in Upper Twelve Mile Creek.

Brookies, as their champions call them, thrive in clean, cold water, like that in Niagara's only remaining such habitat, the Twelve Mile Creek watershed above the Niagara Escarpment. When the brookie population is healthy, that means the creek is thriving, too.

Thanks to an \$8,000 Environmental Grant from the Niagara Community Foundation, the Niagara chapter of Trout Unlimited Canada was able to give both the Twelve and the brookies within it a fin up last year. The group, dedicated to protecting freshwater ecosystems, did it through their Healthy Twelve Mile Creek and Bring Back the Brookies initiatives, which focus on reforestation to mitigate flooding and erosion in critical habitat, and on education.

Both climate change and urbanization have made the former significant issues in the Upper Twelve headwaters, located in Fonthill. That means when it rains, it pours for brook trout because surface water runoff and sediment can flow unfiltered into the creek, warming water temperatures and even smothering spawning beds.



"They've gone from being absolutely abundant to dwindling," Project Co-ordinator Kerry Kennedy said about local brook trout populations.

The community foundation grant enabled Trout Unlimited to orchestrate 18 events with 280 volunteers who planted

6,000 trees, shrubs, grasses, and flowers that will slow runoff after rainfalls, keeping it out of the creek and channelling water back into the ground. The plants also create shade to keep water temperatures hospitably cool for brook trout.

Even better, the reforestation effort got people outside and working together for a common and critical goal at the height of the pandemic.

"It was so much fun to get our hands dirty and get plants into the ground," Kennedy said. "We're very grateful to the Niagara Community Foundation for the funds. Everyone is asking when we can do it again."

COMMUNITY GRANT

Autism Niagara

For autistic children and youth of Niagara, the pandemic has made life more lonely and stressful, and taken away many of the therapies and supports that help them learn and cope.

But an \$8,000 grant from the Niagara Community Foundation's COVID-19 response fund gave the local chapter of Autism Ontario the ability to add some safe fun to their lives.

Families could request kits to do fun at-home activities such as holiday cookie decorating. They were also invited to participate in safe, outdoor activities at events designed for their children's comfort. It was lifesaving to have positive ways to interact with their children or attend events that made them feel safe and free of judgement, said parents.

"The visit to Heartland Forest was such a great experience for our daughter," said one mom. "She loved being able to run freely, to dance, to participate. As parents, it was a relief to be in an environment where there was no judgement of the different behaviours our daughter has. She could be her special self and the other families understood."

"Our son felt comfortable," said another parent. "We are always so grateful to have Autism nights offered. It is a warm feeling being surrounded by other families we can personally relate to."

The pandemic has also hampered the ability of the local chapter, Autism Ontario – South Region, to organize fundraising events, so the grant from the Niagara Community Foundation helped the organization evolve to meet their families' needs. Being able to offer virtual programming, outdoor programming, and take-home kits allowed Autism Ontario – South Region to develop new relationships with local businesses and attractions, which in turn encouraged these community partners to become increasingly mindful of the importance of diversity and creating an inclusive Niagara.



DAVID S. HOWES FUND GRANT

YWCA Safer House: Oakdale Avenue

Being close to an international border comes with serious challenges.

For Niagara, its proximity to the U.S. border makes it an epicentre for human trafficking, with Niagara ranking among the top five Canadian communities for the crime. Furthermore, 75-80 per cent of human trafficking victims come through the Golden Horseshoe.

It's a harrowing infamy underscoring the need for support locally for those escaping such a life. Enter Safer House, a residential program run by the YWCA of Niagara for women and gender-diverse individuals bravely embarking on a life free from the harm inflicted by their traffickers.

With the help of a \$100,000 grant from the David S. Howes Fund, the YWCA hired a support worker to help those living at Safer House to access community resources, attend appointments, and tap into other supports to start moving forward with their lives.

"Sometimes women who are coming into the program don't feel safe going into the community so having a staff member with them helps them feel safe," said Elisabeth Zimmerman, YWCA executive director. "These are people who have experienced a great deal of trauma and are trying to rebuild their lives."

Safer House residents can stay as long as they need. In addition to connecting with community resources, some reconnect with their families after being socially isolated and controlled by their traffickers. Others learn how to live independently or move on to other programs depending on their needs.

"It was a critical grant for us in terms of having a well-rounded program and we've made it very clear the importance of the role for the success of our participants," Zimmerman said. "We have a very strong success rate."

Additionally, the YWCA received \$36,000 from the Howes Fund to purchase furniture and appliances for the common room and offices at its new location on Oakdale Avenue in St. Catharines. Now the organization can use the space to its full potential, including hosting workshops, staff meetings, celebrations, and food preparation for its shelters.




DAVID S. HOWES FUND GRANT Canada Games

Meet the recipient of the largest single grant to date!

We are pleased to announce that in 2021 we made our single largest grant to date, honouring the legacy of the late David S. Howes. \$655,000 from the David S. Howes Fund was granted to the Niagara 2022 Canada Summer Games and the David S. Howes Sport Performance Centre found within the Walker Sport & Ability Centre at Canada Games Park (CGP).

David S. Howes had tremendous passion for sports and the Niagara community. When the 2022 Canada Summer Games' organizing committee came to us with their proposal, we knew that this grant would not only honour David's passions, but it would create a great legacy for Niagara that would last well beyond this summer's Canada Games, which are scheduled to take place from August 6-21, 2022.

The David S. Howes Sports Performance Centre, which has been named in David's honour, is a 6,000 square-foot space that will provide sport services and programs at CGP for high-performance and developing athletes and coaches for years to come. It is a place that will include amenities such as high-performance training and testing equipment, training and testing areas, change rooms and support spaces.



The Foundation is extremely proud to partner with our local Niagara 2022 organizing committee, the various levels of government, the other donors, sponsors and the community at large as excitement builds for the 28th edition of the Canada Games, which will see thousands of up-and-coming athletes, their coaches and support staff gather in Niagara this summer to compete for the podium in Canada's largest multi-sport event.

DONOR DESIGNATED FUNDS

Fiorentino Scholarship Funds

Dr. Lisa Fiorentino had a rewarding and successful career as a professor of nursing and as a university administrator, but the Niagara Falls-born academic knows that the educational path that paved the way to her success is expensive, and not available to everyone.

Meet the fund-holders who received the grants and made a difference in the community.



That's why she and her husband, Dr. K. James Evans, worked with the Niagara Community Foundation to establish a pair of scholarship funds for students at Brock University and Niagara College – to help ease the financial burden of post-secondary education for others.

Dr. Fiorentino and Dr. Evans named the scholarships after her parents and an aunt and uncle, as a tribute to their hard work and entrepreneurial spirit, and to the loving support that made possible her journey through post-secondary education – earning a college diploma followed by Bachelor, Master, and doctorate degrees.

The P. Louis and Philamena A. Giagnorio Fiorentino Scholarship Fund is named after Dr. Fiorentino's parents and will be awarded at Niagara College, while the Peter and Gloria Giagnorio Savelli Scholarship Fund is named after her beloved aunt and uncle and will be awarded at Brock. Fiorentino chose Niagara College because it is where she began her post-secondary career, and she chose Brock because she

wanted to support another Niagara institution that serves so many local students. Earnings from the two funds will flow to the financial aid offices of the two schools, and will be awarded, at the schools' discretion, to returning undergraduate students in good academic standing, who have a demonstrated financial need.

Neither of Dr. Fiorentino's parents had the opportunity to attend college or university, but they knew the importance of education and made it possible for Dr. Fiorentino and her siblings to attend and to graduate debt-free. Dr. Fiorentino and Dr. Evans want to offer that kind of encouragement to other students too.

"Student debt can be crushing for students and their families," she said. With the wise stewardship of the Niagara Community Foundation, "these scholarships will make a difference in the lives of students from the Niagara Region."

ENVIRONMENTAL FUND

Dorothea Thomas Foundation

In 2021, the Foundation was excited to announce the creation of the Dorothea Thomas Foundation, an endowment fund that will be directed exclusively to supporting environmental causes here in Niagara.

With total assets valuing over \$5 million, this new fund will have significant impact on Niagara's environmental sector.

The Thomas family has always been passionate about nature. Niagara and the Golden Horseshoe is one of Ontario's most beautiful regions and while it has to adapt to accommodate changing needs of the community, nature and the environment need our protection. By creating this Fund with the Foundation, the family hopes their support will help maintain – or even improve – the natural habitat we are blessed with.

The Dorothea Thomas Foundation is a Field of Interest fund, giving NCF's Environmental Grants Program a significant boost. Environmental grants are dispersed early in the new year so the organizations can put the funds to work each spring with the goal to achieve tangible, positive results. While research and modeling are useful first steps, models are a tool to guide action. The types of projects this new fund is looking to support are ones that will have a direct and immediate impact on the surrounding environment and ecosystems throughout Niagara.

Part of the Foundation's External Fund Manager Program, a third party investment manager – Cooper Wealth Management – will manage the Dorothea Thomas Foundation. This fund further demonstrates the trusted relationship NCF has with allied professionals across Niagara. "Transferring our assets to NCF was an easy choice for us," says a member of the Thomas family. "We were still able to keep our investment team and allow NCF to fulfill our philanthropic wishes. It was a win-win."

CHARITABLE ORGANIZATION FUND

The RAFT Endowment Fund

When a donor provided the RAFT with a \$100,000 gift in 2020, they did so with some specific requests.

The money was to be used for housing. The RAFT, which provides support services for at-risk and homeless youth, also had to ensure the gift's legacy and longevity.

Enter the Niagara Community Foundation and Executive Director Bryan Rose, who helped the RAFT establish a namesake fund that would support Niagara youth for years to come.

"The main concern was making sure the donor was satisfied with how we were investing the money," said Michael Lethby, RAFT executive director. "Bryan laid out the options for us and tailored it to what we needed."

The result is a fund whose dividends are used to provide monthly rental supplements between \$250 and \$350 to RAFT clients.

About 40 per cent of the youth the RAFT supports live outside of Niagara's three main urban centres where there's constricted rental housing supply and, like elsewhere in the region, rents are high. Meanwhile, the average monthly Ontario Works payment a young person receives to cover all living expenses is about \$700. In comparison, rent for a one-bedroom apartment exceeds \$1,000 a month.

Uprooting a client to bring them to the RAFT's 16-bed shelter in St. Catharines isn't a viable alternative, Lethby explained. It takes a vulnerable youth out of their community and away from their support network.

Using The RAFT Fund to help with rent supplements ensures some stability, he said — for both RAFT clients and the organization itself.

"That's an established fund and we're hoping other donors see that and donate to the fund," Lethby said. "It's something we thought was a real benefit to going this route with the Niagara Community Foundation. It makes us feel part of the community to have this, and there's a sense of permanency to what we're doing as well."

DONOR DIRECTED FUND

Dr. John Hunter Fund

It wasn't every day that Dr. John Hunter was able to join his daughter Victoria when she walked her son to kindergarten in the morning.

As a busy obstetrician and gynecologist at West Lincoln Memorial Hospital in Grimsby, Dr. Hunter was on call 24/7, so it was a rare treat to have him part of their daily routine.

But that morning walk, which happened about 20 years ago, was memorable for another reason.

"He easily delivered 50 per cent of the kids in that kindergarten line," Victoria recalled. "He was a big part of the community here."

That's why, after Dr. Hunter's death in 2016, Victoria chose to honour her father by establishing the Dr. John Hunter Memorial Fund with the Niagara Community Foundation. Victoria, who is part of the community foundation's Grimsby Community Fund committee, already knew the broad impact that a fund managed by the Niagara Community Foundation could have on a community or cause.

It also does something else. It keeps Dr. Hunter's memory alive in the community he served while giving back to the place Victoria and her husband Andrew had the good fortune of raising their boys.

"People stop me and tell me how much they loved my father and how much he helped them through difficult pregnancies," Victoria said. "That always warms my heart. He cared deeply about his patients and they were always his priority."

The fund continues to look after those for whom Dr. Hunter cared. The memorial fund will support youth mental health care at West Lincoln Memorial Hospital.

"It's also for the kids he delivered and the young adults they have become, as well as the next generation of children who have been having a difficult time, especially through COVID," Victoria said. "I thought this fund would be a special and useful way to pay it forward. It's keeping the money close to home but also taking care of the youth and our Grimsby community."



DONOR ADVISED FUND

Agape Series Fund: J.L. Garrett & Family

Jim Garrett and Alice Klamer see generosity as a way of life and a way of loving.


That's why they named their family fund with the Niagara Community Foundation the Agape Series Fund – incorporating the ancient Greek word for love that is found in the Bible.

Their fund, established in December 2020 with money that Garrett jokingly told his children was originally saved for a sports car, is meant to continue growing long after Garrett and Klamer are gone, and continue to benefit some of the children's charities that are dear to the couple's heart: Red Roof Retreat, Big Brothers Big Sisters, and Youth Unlimited, thus Garrett and Klamer also established sub funds in 2021/22 for each of these charities as well.

The work of these organizations, and the way they care for vulnerable children and families and give young people meaning and hope, are important to Garrett and Klamer, and they want to be able to support this work for many years. They also expect their adult children to help make decisions about future disbursements from the main Agape fund, so establishing the fund now gives them a chance to talk with the next generation about their priorities, and the importance of generosity. That generosity is something they saw modeled by their own parents, and a gift they want to pass on to their children that they think is even more important than money itself.

Garrett said agape love is the highest form of love – doing something with absolutely no expectation of return. Garrett and Klamer, who through their faith, consider themselves to have been richly blessed and they want to always pay it forward.

"I am hoping that this will be important to our children and grandchildren," Garrett said, "and that it will be a meaningful way for us to continue to help others."



DONOR DIRECTED FUND

Michael Berlis & Ellen Cheslock Fund

When Michael Berlis and Ellen Cheslock retired to Niagara-on-the-Lake more than 15 years ago, they weren't about to quietly retreat into their golden years.

They did everything imaginable to get involved in their new hometown. Berlis, for example, worked at a winery and then helped found one of the first breweries on Niagara's Ale Trail. He joined a local gastronomic and social club. Then he became chair of the Niagara Community Foundation's Niagara-on-the-Lake Fund in support of organizations and initiatives dedicated to making life even better for residents.

In the process, the couple fell in love with their adopted community, proud to show it off to anyone who stopped in for a visit.

To show how much they appreciate life in Niagara-on-the-Lake, the couple established the Michael Berlis-Ellen Cheslock Fund through the Niagara Community Foundation.

"You get involved with different aspects and then look for ways to give back to the community," Berlis said. "The Community Foundation is a part of that. The main driving force behind starting this fund is that the money stays in the local community."

Berlis and Cheslock started their fund with a lump sum and plan to add to it over the years ahead to help it grow and meet the ever-changing needs of Niagara-on-the-Lake.

Right now, mental health, particularly children's well-being, has become a priority due to the pressures of living in a pandemic, Berlis noted. He and Cheslock are also aware of the difficulties charities in general have had with fundraising over the past two years to help some of those causes.

"Charities are important, but they may be even more important today than they were before. There are needs that will emerge that will need to be monitored. Niagara-on-the-Lake is not immune to the issues that COVID has created."

Endowment Funds


The Foundation has a different face to each of our donors. Their funds can support a particular cause, community or charity and once a fund is opened anyone can make gifts of any amount, in any way, at any time. Donations can also be made in honour or memory of a loved one.

There are many ways to make a gift to the Foundation. These include cash, securities, bequests, special event proceeds, property, and insurance policies. Our role is to work with donors to ensure that their charitable intent is achieved through their gift.

There are a number of options for donors when considering how long they would like their fund to be active. Most of our funds are held in perpetuity, where the capital is preserved and a portion of the annual earnings on the fund are allocated to charities. Funds can also be held for a specific length of time or established to have a fixed annual distribution. In these later two examples both the capital and the earnings are distributed.

However, with increasing demands for support, it is important to take the time to determine how to make 'the best gift', a gift that provides maximum benefits to the community that is within one's capacity to give. We strongly advise donors to speak to their family, lawyer, accountant or financial planner to determine the best way to make a gift that maximizes their tax and estate goals.





2021 Financial and Governance Highlights

GOVERNANCE

The Board's role is to set policy and to question, scrutinize and monitor the management of the Foundation's affairs. It is a role of governance as opposed to operational management. The Board's primary responsibility is to build and ensure sound management of the Foundation. It oversees the Foundation's management and ensures that the affairs of the Foundation are being conducted in a manner that achieves its goals, consistent with the Foundation's mission. The Board meets five times throughout the year plus a special meeting for strategic planning. The Role of Board and Executive and the Scope of Authority policies are in place to delineate responsibility between board and staff. The Board has also adopted a Code of Ethics and Confidentiality policy for board, staff and volunteers.

OPERATIONS

The Foundation's staff is led by the Executive Director, who reports to an independent board of directors. Operating costs include asset development, charitable activities, special projects, administration and governance. NCF also received funding in 2021 from Niagara Region to support the Niagara Prosperity Initiative. This funding enables us to bring key groups together to guide poverty reduction initiatives.

Fund development, administration and governance expenses for the fiscal year ended December 31, 2021 totaled \$728,901. This figure does not include special projects that were funded separately from normal operating revenue. The expense of development activities is not necessarily related to the donations received in any one year and gift delays result in costs preceding the receipt of gifts by several years (for example, gifts in wills and life insurance). As a result, consistent with the community foundation sector, operating costs are evaluated by a ratio of total core operating expenses (excluding special projects) to total assets. For 2021, that percentage was 0.98% (compared to 0.95% in 2020, 0.82% in 2019 and 1.03% in 2018), which continues to be well below the range of community foundations of similar size and stage of development. Each endowment fund is charged a pro-rated administration fee of a maximum of 1.25% to offset expenses.

INVESTMENT FEES AND RETURNS

The Foundation's investments are pooled with a number of other public foundations and charities in an investment pool with the Toronto Foundation (TF). This relationship has been in place since 2001 and is re-evaluated on a regular basis by the Investment Committee.

The endowments are invested in accordance with the investment policy established by TF's Board and are part of the Niagara Community Foundation's Investment Management Agreement with TF. Our Investment Policy is available at niagaracommunityfoundation.org. All portfolios are managed by professional investment managers and in accordance with the policy.

* Global Equities may include Canadian, US, International and Emerging Markets equities. They may be diversified by size (large cap, small and mid-cap), style (value & growth) and other factors such as high dividend stocks.

** Other Strategies may include benchmark-free and absolute return strategies.

The average investment fee paid for 2021 was 0.50% for funds in the TF investment pool. The investment fee is charged monthly to each fund on a pro-rated basis. The Foundation's annualized five-year (2017 to 2021) rate of return is 5.3% (net of fees).

EXTERNAL INVESTMENT MANAGERS PROGRAM

The Foundation is always looking for new ways to help donors in achieving their philanthropic goals and to work with professionals in the financial, estate and investment world in mutually beneficial relationships. In 2012, the Foundation created the External Investment Managers Program which allows assets gifted to a newly created fund to be invested outside of Foundation's Consolidated Investment Fund in a portfolio managed by the donor's recommended investment firm. This program is available for advisors who have been licensed as a portfolio manager actively involved in discretionary investment management of segregated portfolios for a minimum of three years. The minimum donation required for a fund manager to participate in this program is \$1,000,000. Gifts under this amount will be considered on a case-by-case basis. There are currently six funds under the management of five portfolio managers participating in this program.

SOCIAL IMPACT INVESTING

In November 2012, the Board of the Foundation made a commitment to invest \$500,000 in the Community Forward Fund (CFF), a social finance investment fund. The initial draw on this investment took place in February 2014. As of December 31, 2021 the Foundation's commitment of \$500,000 was fully deployed. For 2020 the investment returns on the CFF were 3% (unaudited as of March 2021).

The Foundation's Board took another step into the realm of Social Impact Investing entering into a \$100,000 partnership with the Fair Finance Fund (FFF) – a new social finance fund for the Ontario food and farm sector. The Fund lends to social enterprises across the food system that provide demonstrable social, environmental, and economic benefits. Every penny invested goes directly to loans. This innovative fund supports the future of local food in Ontario, from seed to supper. For 2021 the investment returns on this fund were 4.0%.

As with all Social Impact Investment opportunities, the Foundation recognizes that although there might be a lower financial return compared to that of traditional investments, that there is an equally important social and environmental impact alongside of the financial return.

RISK MANAGEMENT

The Board has a comprehensive Risk Management Policy covering legislative and legal, fiscal performance, financial reporting, management of volunteers, effective management and governance, economic risk, and donor and volunteer stewardship. The Finance Committee reviews the Foundation's exposure to risk and mitigants to address perceived or actual risks annually. The Board regularly considers risk exposure as part of its deliberations. The price risk related to investments arises due to fluctuations as a result of changes in market prices whether those changes are caused by factors specific to the individual security or its issuer or factors affecting all securities traded in the market. Accordingly, the Foundation is exposed to the effects of the market fluctuations. While market risk cannot be eliminated, the Foundation's Investment Policy addresses this risk with parameters for both asset quality and diversification.

OPERATING RESERVE FUND

In 2018, on the recommendation of the Foundation's Finance Committee, the Board made the decision to create an Operating Reserve Fund with the accrued surplus revenue from our Operating Fund year-over-year. Operating Reserves are liquid, unrestricted assets the Foundation can use to support our operations in the event of an unanticipated loss of revenue or increase in expenses. The reality of market fluctuations have an impact on the Foundation's source of income and an Operating Reserve Fund provides comfort to the Board and our fundholders that the Foundation has the breathing room

and the ability to respond to a rapidly evolving financial landscape. The Foundation's goal for our Operating Reserve Fund is six months of our annual Operating Budget to cover all major expenses (rent, pay-roll, etc.).

ACCREDITATION

In 2012, the Foundation received accreditation through Imagine Canada's Standards Program. The Foundation was one of the first community foundations accredited in Canada. The program offers a Canada-wide set of shared standards for charities and nonprofits wishing to enhance their effectiveness in the fundamentals of governance, paid-staff management, financial accountability, fundraising and volunteer management. The program includes a voluntary accreditation program for organizations wishing to publicly demonstrate they have successfully met the standards through a third-party peer review process.

EVALUATION

The Board has adopted a comprehensive annual process to evaluate its performance. The results of the evaluation are reviewed at its November meeting where actions to improve board performance are implemented. Moving forward the evaluation will be reviewed at the April meeting. This process is done on a biennial basis with Foundation committees. Employees of the Foundation participate in bi-annual performance appraisals, which include on-going review throughout the year. The Executive Director's review is presented bi-annually to the Board by the Board Chair.

COMPENSATION

The Board has established salary ranges for each of the Foundation employees. The ranges are determined based on reviewing similar positions within the community foundation sector across Canada as well as similar positions within Niagara. Ranges are adjusted regularly to reflect cost of living changes. Movement through the range is dependent on performance.

BOARD RECRUITMENT, ORIENTATION AND TRAINING

The Bylaws of the Foundation set out the Board recruitment process. Nominees from across Niagara are identified based on current board attributes and future strategic needs. The Board is comprised of 17 members who are elected for a three-year term, which can be renewed once. The term can be extended if a Director is serving as the Vice-Chair, Chair or Past-Chair. New Directors take part in a formal orientation program. Board training takes place at each meeting and additional opportunities are provided throughout the year for members to participate in professional development provided by Community Foundations of Canada.



